The date of September 5, 2024 at 7:00 p.m. was set for the commission to meet for their review of eligible candidates who participated in our polygraph testing process.

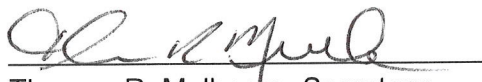
6. Adjournment
