Reports:

- Mayor Gunter announced the Rotary Pancake Breakfast & Holly Days celebrations
- Manager May talked about how well the entities work together, Quincy St project, and China Chef
- Director Fleck discussed cooperation, efficiency, the Natatorium, Police Department, Schools, Special Events, the 4th of July, drones, pickleball, Holly Days Parade on 12/2, & the skate park - how well everyone works together.
- Trustee Barker - Commented on the events and how well the Village & Park District work together, the downtown park and Addington Plaza.

New Business

Village of Westmont/Park District Relationship - Intergovernmental Agreements

Mayor Gunter addressed the historical cooperation of the Village and the Park District. He referenced the document listing highlights of this relationship dating back to the 1970's, which was presented to those at the meeting. He then reviewed intergovernmental agreements. Executive Director Fleck agreed with the positive relationship between the two agencies. He then commented on the recent formation of the Decennial Efficiency Committee. He explained the purpose of the Committee, indicating that this listing of the Village/Park relationship is helpful documentation for the Efficiency Committee.

Village Manager May confirmed the positive relationship between the Village and Park District, noting that other communities do not have this relationship. Park Commissioners and Village Trustees agreed. Mayor Gunter and Executive Director Fleck also discussed cooperative efforts between the two agencies, such as the July 4th Celebration and Holly Days Events.

Stormwater Management Opportunities Overview

There was no discussion of stormwater management opportunities.

Capital Projects Overview

Executive Director Fleck reported on the progress of the new multi-purpose building currently under construction at Veterans Memorial Park, stating that it is the biggest capital project going on now. In addition, the District is looking to create six permanent pickleball courts at Bellerive Park, where the skate park is currently located. The plan is to move the skate park to Diane Main Park. He referenced the IGA with the Village to create the skate park, as this facility is now nearing the end of its useful life.

Miscellaneous

Other topics discussed include open green spaces in Downtown Westmont, which may be considered for future park sites; the current development of a plaza/outdoor eating area on West Quincy Street; and the future development of the "S" curve area at Cass and Burlington Avenues. Finally, an overpass or underpass at the railroad crossing on Cass Avenue was discussed.

Seeing no further business to discuss, a motion to adjourn the Special Joint Meeting was made by Village Trustee Liddle and seconded by Village Trustee Brady.
